**VACANCIES FOR THE POST OF INSURANCE OMBUDSMAN
AT VARIOUS CENTRES**

Office of Executive Council of Insurers (ECOI) invites applications for appointment of Insurance Ombudsman for a term of 3 (three) years at Ahmedabad, Delhi, Bhubaneswar, Kolkata, Lucknow, Patna, Pune, and Noida from persons who fulfill the following eligibility criteria:-

Minimum Eligibility (as on 9.11.2018)	The applicant should have at least 25 years' experience in insurance industry at senior level with last position held at most one level below Board. OR The applicant who has retired or is soon to retire from Civil or Administrative services of Government of India. The candidate should have held a post of Joint Secretary or equivalent in the Government of India or any equivalent post in Civil or Administrative services of Government of India OR The applicant should be a person who has retired or is soon to retire as District & Sessions Court Judge or Judge of MACT equivalent to District & Sessions Court Judge or equivalent Courts or High Court Judge.
Age (as on 9.11.2018)	Not below 58 years and not more than 67 years, provided that no person shall hold office as an Ombudsman after he has attained the age of seventy years.
Re-appointment of Ombudsman	An Ombudsman who has successfully completed 3 (three) years of service and is not more than 67 years (as on 9.11.2018) is also eligible to apply provided that no person shall hold office as an Ombudsman after he has attained the age of seventy years.

Appointment of a selected candidate will be subject to

- (i) vigilance clearance from the immediate previous employer, and
- (ii) a satisfactory medical fitness report from a doctor (who is a Divisional Medical Referee or Zonal Medical Referee of Life Insurance Corporation of India).

The interested applicants may clearly indicate their willingness to work at any of the location mentioned herein above.

Last date for receipt of application **9.11.2018**.

The Insurance Ombudsman selected shall be appointed at any of the centres.

The Ombudsman shall be allowed a fixed pay of two lakh twenty-five thousand rupees per month and any pension to which he is entitled from the Central Government or a State Government shall be deducted from his salary.

Other allowances and perquisites payable to the Ombudsman shall be such as may be determined by the Executive Council of Insurers with the prior approval of the Central Government.

The Selection of candidates will be made by a Selection Committee constituted as per provisions of Insurance Ombudsman Rules, 2017.

The interested applicants shall send an application in the attached format which should be accompanied by a CV (mandatory) giving full details at the following address so as to be received in office of Executive Council of Insurers on or before **9.11.2018**.
